

JOB DESCRIPTION

POSITION TITLE: Overnight Youth Care Worker

SUPERVISED BY: Supervisor – Youth Care

SUPERVISES: No One

PURPOSE OF POSITION: To supervise and ensure the safety of the milieu while alone during the night when Youth are sleeping, and to act as an advocate, educator, coach and role model for the residents of Mercy Home for Boys and Girls when the Youth are awake.

ESSENTIAL QUALIFICATIONS:

- At least 21 years of age.
- Bachelor's degree or equivalent experience.
- Ability to stay awake during hours of rest for the Youth.
- At least two years experience working with youth.
- A valid Illinois driver's license, ability to drive a van, maintain a clear driving record, and retain driving approval through the Department of Children and Family Services.
- Regular and predictable attendance.
- Ability to work both independently and as an active team member.
- Excellent interpersonal, oral, and written communication skills.
- Maturity and sensitivity to cultural and individual differences.
- Ability to maintain professional demeanor while exercising judgment and discretion in work.
- Ability to follow oral and written instructions.
- Ability to read and interpret documents such as operating and maintenance instructions, procedure manuals, and professional journals. Ability to write reports and correspondence.
- Proficiency in Microsoft Word and Excel, as well as the ability to become proficient in other software packages and programs.
- Ability to maintain confidentiality.
- Ability to lift and/or move up to 40 pounds, and with proper training, be able to physically restrain youth.
- Commitment to the mission, values, and goals of the Agency.

ESSENTIAL FUNCTIONS:

- Supervise and ensure safety of the milieu during the night when Youth are sleeping.
- Be responsible for the implementation of each Youth's ITP, in particular their targeted case load.
- Be accountable to ensure the Youth's educational, employment and treatment plans are followed.
- Be responsible for timely and accurate communication within program, i.e., incident reports, contact with Youth's, families, supervision, and all log entries.
- Build a therapeutic relationship with youth by being a teacher and a coach as it relates to bed time and as needed through the overnight shift.
- Provide leadership for the Youth in the provision of a healthy living environment, i.e., consistent and supportive supervision of Youth's life space.
- Participate in supervisory meetings appropriate for job function.
- Restrain Youth as necessary.
- Provide transportation for Youth as necessary.
- Learn Wingspan and complete the Daily Population Sheet
- Supervise Program space as specified by the supervisor.
